I. <u>CALL TO ORDER</u>

The meeting was called to order at 4:40 p.m. by Nicholas Kakos, vice-chair, in Conference Room 333 of City Hall.

II. <u>APPROVAL OF THE AGENDA</u>

IV. <u>POLICY ITEMS</u>

At this point in the meeting Nicholas Kakos turned the meeting over to the chair, Jackie Cherryhomes

1. Report of the Nominating Committee [NRP / PBR#2000-06]

Sharon Sayles Belton chaired the nominating committee and presented their report. The nominations are as follows; for chair Hennepin County Commissioner Mark Stenglein, for vice-chair Protection Neighborhood Representative Nicholas Kakos and for Secretary Minneapolis Central Labor Union Representative Ken Kelash. She then moved the slate of officers submitted by the Nominating Committee. Clareyse Nelson seconded the motion and the motion carried unanimously.

At this point in the meeting Mark Stenglein assumed the chair, thanked Jackie Cherryhomes for her leadership of the Policy Board for the past two years and continued the meeting.

2. Phase II Planning

[NRP / PBR#2000-07]

Jeff Schneider presented a status report on Phase II Operational Models. The report was submitted so that Policy Board members would have an opportunity to provide some feedback on the core principles and policy issues that should be addressed as the models are being developed. Nicholas Kakos asked if the staff's working meetings are open to the public. Mr. Schneider replied that they were open meetings. Judy Schwartau then asked about the Teamworks evaluation; when it will be completed and how it will be presented. Kent Robbins replied that a draft of the evaluation is expected by the end of April, however, he indicated that Kathleen O'Brien will be coming to the Policy Board with suggestions for the presentation of the evaluation. Jackie Cherryhomes then moved and Nicholas Kakos seconded that the Phase II status report be received and filed. The second item presented was schedule of dates for presentation of the selected models to the public prior to final Policy Board approval. Jackie Cherryhomes moved and Nicholas Kakos seconded adoption of the "Public Response to a Selected Model for Phase II" as presented. Both motions carried.

1. Hennepin County "Second 7.5%" funds for Near North / Willard Hay
